
In the name of and by the Authority of the State of Florida:

The Grand Jurors of the State of Florida, impaneled and sworn to inquire and true presentment make in and for the County of Glades upon their oath do present that **THEOPHILUS TAWON BROOKS**, in the County of Glades and State of Florida, did unlawfully:

1. Between February 07, 2011 and February 11, 2011 in Glades County, Florida, did unlawfully from a premeditated design to effect the death of a human being, kill and murder Erica Vassell a human being, by shooting her with a firearm or beating her with an object or running her over with a vehicle or any combination thereof, and during the commission of said offense did actually possess and discharge a firearm, and as a result of the discharge did cause death or great bodily harm, contrary to Florida Statute 782.04(1);775.087; 777.011,


and against the peace and dignity of the State of Florida.
