

#### **First Degree Murder Case**

Vernon Stevens was found guilty of First Degree Murder, First Degree Arson of a Dwelling and Robbery with a Deadly Weapon. This was for the 2007 murder of Antonio Beltran. Following the guilty verdict was the penalty phase of the trial where the LaBelle jury recommended life in prison for Stevens

The judge will have the final say in sentencing. Assistant State Attorneys Dan Feinberg of our Homicide Unit, Jennifer Gutmore and Denise Kiser handled the case.

Raymond Diaz, the co-defendant in this case has already pled to Second Degree Murder, Arson of a Dwelling and Robbery with a Deadly Weapon.



#### **Suspicious Person**


\_Watson Lwellyn Lewing was found guilty of Exposure of Sexual Organs and Breach of Peace following a one day trial in Lee County. The case involved a suspicious man, Lewing, at Hancock Park in Cape Coral. Police were called to the scene by parents who were there as their children were having Pop Warner football practice.


One parent went to the suspicious person to see if they needed assistance. When they walked over, Lewing was seen sitting on a park bench with his erect genitals fully exposed.

The jury took only 10 minutes to come back with a guilty verdict. Lewing was sentenced to a sentence of 30 days in jail followed by 18 months of probation. Assistant State Attorney Matthew Roepstorff handled the case.

#### Crime Against a Child

Brandon Church was found guilty of an Unnnatural and Lascivious Act following a 2 day trial in Lee County. Church was arrested after being found with his genitals exposed while hovering over a 9 year old girl who was laying in bed. The 26-year-old defendant is a Prison Releasee Re-Offender and an Habitual Felony Offender. Assistant State Attorney Tyler Lovejoy handled the case.

#### **Domestic Violence Case**

Hector Jiminez Vasquez was sentenced to the maximum of one year in jail after being found guilty of Domestic Violence Battery. The victim had been punched, dragged, shoved under a vehicle, then kicked and punched while under that vehicle. Assistant State Attorneys Jennifer Toussaint and Will Grauel of our Naples office handled the case.



#### **Obscene Calls**

Defendant Arthur Krell was found guilty of making Obscene Phone Calls following a one day trial in Punta Gorda. Krell said obscene things to a victim and a deputy over the course of 40 phone calls. The defendant was sentenced to 6 months of probation. Krell must also complete community service hours, an anger management class and write letters of apology to both the victim and the deputy. Assistant State Attorney Caitlin Sorenson handled the case.

#### **Shoplifting Case**

A shoplifting trip to a Charlotte County Wal-Mart ended with the defendant, Jeffrey Desrivieres spending one year in jail. He was spotted by a Wal-Mart loss prevention officer taking items and concealing them on him in places throughout the store. As Desrivieres walked out the door he was confronted by the officer. Everything he had stolen was found on him.

The jury deliberated for only 5 minutes. The one year sentence is because of his criminal history. Assistant State Attorney Caitlin Sorenson handled the case.
