
Life in Prison

Defendant Michael Sheeley was sentenced to life in prison for a murder in Charlotte County.

He was found guilty of Second Degree Murder, Fraudulent Use of a Credit Card, Grand Theft of a Motor Vehicle, Dealing in Stolen Property and False Verification of Ownership/ID to a Pawnbroker.

In this case Sheeley murdered a 75 year-old man. He attacked him and then stole his car, used his credit card and pawned the victim's jewelry. He was caught after trying to cash a check at the bank in his name on the victim's account. The bank called the daughter to let her know they were suspicious and she found her father unresponsive on the ground. He died a week later.


The trial in Charlotte County lasted 4 days and the state called 17 witnesses. Assistant State Attorneys Andreas Gardiner of our Homicide Unit and Jennifer Garczewski handled the case.



Murder Sentencing

Abraham Eckman was sentenced to 25 years in prison for a murder in Collier County in 2012. Eckman fired a gun through a window killing a 25 year-old who was asleep.

The victim was in a relationship with Eckman's former girlfriend and mother of his child. 27-year-old Eckman plead guilty to Second Degree Murder with a Firearm. Assistant State Attorney Lisa Mead handled the case.



Gambling Case

Clifford Wayne Davis was found guilty of Maintaining a Gambling Establishment. Casino style gambling machines and high stakes poker games were part what was found at a Fraternal Organization in Cape Coral. A special agent with the Florida Division of Alcoholic Beverages & Tobacco investigated. They then served a search warrant and seized items including a poker table, chips and cash.

The Lee County jury deliberated for 20 minutes before returning the guilty verdict. Sentencing is scheduled for June 13th. Assistant StateAttorney Simon Eth handled the case.



Fred Cooper Case

The Second District Court of Appeals denied Fred Cooper's post conviction motion challenging the effectiveness of his attorneys. The same appellate court previously affirmed the conviction and sentence. In 2005 Cooper murdered Steven and Michelle Andrews in their Gateway home in Lee County. He was sentenced to three life sentences after being found guilty of the two counts of First Degree Murder and one count of Burglary with an Assault or Battery While Armed. Cooper had been indicted by a grand jury.

The event, which is open to the public, will be held at IHeart radio studios located at 13320 Metro Parkway from 10 a.m. to 1:00pm, with limited seating available.

"Seniors Fighting Back" is geared specifically to older adults, caregivers, and community members concerned about elder exploitation and abuse that have the desire to better understand this complex issue.

Lee County Sheriff Mike Scott and State Attorney Steve Russell will be guest speakers, along with members of their respective Economic Crimes and Elderly Fraud Units.

Local organizations involved in the prevention of and response to elder abuse will also be onhand to answer your questions and provide information. Among the government, social service agencies and community organizations participating in "Seniors Fighting Back" will be Adult Protective Services, Department of Agriculture and Consumer Services, Seniors vs. Crime, Florida State Guardianship Association, The Alvin Dubin Alzheimer's Resource Center, the Academy of Florida Elder Law Attorneys, Lee Elder Abuse Prevention Partnership, Senior Service Representatives from the Sheriff's Office, Southwest Florida Security Association, Area Agency on Aging Southwest Florida, and the State of Florida Ombudsman Program.

This is a free event with wheelchair accessibility and plenty of parking. Light refreshments will be served.
