RETIRED LAW ENFORCEMENT OFFICER ARRESTED

On August 11, 2006, the Office of the State Attorney filed an information alleging that Thomas Boysen, a white male born October 24, 1949 did commit attempted sexual battery and a sexual battery (see attached information). Boysen's address is being withheld based upon his status as a retired law enforcement officer. The Court issued a capias directing the arrest of Boysen and bail was set at \$15,000 (see attached Capias).

These charges are based upon an investigation conducted by the Florida Department of Law Enforcement.

The crimes with which Boysen has been charged occurred while Boysen was acting in his custodial and/or official authority as a supervisor of the Charlotte County Sheriff's Office's Explorer program. The victim was an explorer in the Charlotte County Sheriff's Office's Explorer program and participating in said program at the time of the commission of the alleged offenses.

Agents of the Florida Department of Law Enforcement arrested Boysen on August 11, 2006 in Port Charlotte. Boysen posted bond on August 12, 2006 and must appear before the Honorable Judge J. Frank Porter on September 18, 2006 at 8:30 am for arraignment.
